NEIGHBORHOOD SAFETY - RECENT ATTACKS

Theodore Chisholm, Chief of staff of the Sheriffs Department spoke at this meeting in regards to the recent increase in the number of strong arm robberies in and around the Humboldt Park area. Milwaukee Police have a suspect for the incident which occurred on Friday, March 26, 2021 but have not released much information. They are following up on the other incidents. The park patrol will start early this year because of the early occurrences of dangerous events. There is not enough in the budget for a year round patrol. For the patrol they pull employees away from Court House and airport security teams. There usually are 10 to 15 on park patrol from 4 pm. To 12 pm. They work hand and hand with the Park Rangers. Park Rangers are not trained for inter-personal reactions and mostly deal with County Ordinances and traffic.

Brad Sliney is starting highly visible patrols with the 6th district. The patrol cars will be coming off the expressway and going through the parks. Bike patrol will also be stepped up. Low visibility monitoring will also be done. A representative from the Sheriffs staff will be able to attend future meetings. Let Jason Haas know of any occurrences or problems. If there is an emergency always call 911. Call 414-278-4788 for non emergency concerns. The county deals with less calls so that number could get results faster than the city. The mobile app. is being redone and should be ready in approximately 2 weeks. Mr. Chisholm's number is 414-639-5263.

Lagoon Restoration

The parks department has no extra money or a scientific number of employees for us to start any fund raising at this time. They will let us do some investigation work. Storm water Solutions Environmental Company is willing to work on collecting information. Their proposal for Phase 1 was \$15,000.00. They will provide a new proposal since Landscape Architects will not be used at this time. Proposal could be done in 2-3 weeks. Any information we gather belongs to the park, also.

The committee is hopeful that a cattail removal can be accomplished this year at some point. The last time the county did a removal was 11 years ago.

Discussion of becoming our own non-profit was thrown around. It seems the process has become easier. The drawbacks are the cost of insurance, year end costs and personal liability.

100 Trees for Humboldt:

Stakes are in the ground for the proposed locations of the spring plantings. The forester will be selecting the tree locations.

If anyone happens to see trees being planted or holes being dug, please take some videos or pictures.

John L.Barber, a county forester, passed away, so we would like to plant a tree in his memory. In regards to groups receiving medallions it was suggested that the medallion could be displayed in their buildings if they had one.

If the county would let us display a recognition wall for whole ,as well as partial tree donors, that would be great. It could be a tree with leaves naming the donors. Jane said there is something similar in the main building at Wehr park.

We could present this at a county meeting with some back up possibly from our county supervisors. Need a positive plan to present to them.

Active Streets

The county has taken over the Active Street program for county parks.
