## **Lagoon Restoration Committee**

No meeting of the Committee occurred. No outreach with MCP occured. Patrick was requested to contact MCP and advance request by Lagoon Committee

#### 100 for Humboldt

Several staked tree locations along the Oklahoma edge east of Pine were noted. No opportunity is being provided to better address short comings of planting practices by planting crews. Mike noted MCP has GIS location and cultivar information for previously planted trees. Access to this information remains outstanding. Current communications and singular engagement structure with MCP remains an obstacle to insure better planting practices are provided.

Henry noted the two Tree Day plantings along 600 East Montana are being adjusted to establish the root flare. Henry is conducting the work. 3" of excess soils were removed at the Burr Oak. Interested members were invited to observe adjustment for the Red Oak. Kyle and Jane agreed to observe.

Cost information will be requested by Mike of MCP. Discussion noted HPF can be involved to organize efforts to fund repair and lead discussion on overall plans thought additionally necessary.
